### Summary of Human Rights Violations in Sudan from September 2017

#### Submission to Human Rights Council Session No ( 39)

There are no improvements in human right record of Khartoum regime since the last human right session in Geneva ( 36 ) 2017. On the contrary, there are more extensive human right violations since then.

**First:** The right to live and to exist has been threatened, the regime imposed stern economic astringents on the people leading to unbearable increase of prices and lack of basic needs like bread, fuel and similar requirements.

**Second:** The regime failed to provide medical treatments even in case of emergency. Prepaid heavy cost is required, Many people are not able to pay and patients face death, Social media mentioned the case of child brought by his parents from Madani to Khartoum government hospital in a state of emergency but denied admission to the government hospital due to inability to pay heavy costs and the child pass away at the threshold of the government hospital.

**Third:** Banks failed to meet the request of costumers to withdraw from their accounts and savings and also government employees could not withdraw their monthly pay, thousands of customers and employees stand in long queues for hours short of withdrawing their entitlements. Banks have no money and the government and associates embezzled the savings of costumers. Consequently, many could not meet their basic needs including foods, medical treatment and house rent.

**Fourth:** All oppressive laws are still in operation e.g. State security law 2010, Public order law, Press law and emergency laws in sates of Darfur ,Kordufan,Blue Nile and Kassala .Citizens and human rights activists suffer under these laws. They are arrested, detained, daily summoned and tortured and denied access to family, lawyers or medical treatment. Women are still being detained, harassed, insulted, tortured and whipped for their dress.

**Fifth:** Sudanese are not safe and are daily venerable to rape, torture and homicide in many places haunted by government militias of Raped Support forces ( RSF ) specially in Darfur , south kordufan , blue Nile and Kassala. RSF, not bound by any law and backed by unfettered immunity may beat any person, Rob and loot, arrest and detained. They beat doctors when performing their medical dutes, they did so at Kassala hospital and Elobeid hospital in Kordufan. One of RSF attacked two female doctors at Elobaid hospital in August 2018. All doctors in the hospital claimed that offender be accountable.

Instead the doctors were arrested including:-

This gives unrestricted license to offenders from RSF to commit crimes in return of suppressing political opponents.

**Sixth:** Freedom of expression is denied. Newspapers are repeatedly confiscated by National Intelligent Security Service ( NISS ) after printing causing heavy losses to newspapers. Many journalists are banned from writing or dismissed.

**Seventh:** In September 2013 more than two hundred young Sudanese, men and women, were murdered by the regime when they were in peaceful demonstrations against high pricing of commodities. There have been repeated demands from the international community for independent fair inquiry. The regime refused to respond. It shall not respond because it a wrong-doer. It well known that the victims were deliberately murdered by the militias of the regime and NISS. International inquiry and a decision to this effect is urgently needed.

**Eights:** Some cases of human rights violations since last year 2017 are as follows:-

- 1/ On 28 /08/2017 government militias invaded Kassal University, arrested and tortured students including Mohamed Mustafa Salim and Idris Mohamed Sidi Faki from DUP.
- 2/ On 09/09/2017 NISS arrested and tortured **Mr Mohamed Gadallah**, students in Nileen university Khartoum, who was with others celebrating the killing by the regime of students at Islamic university in Omdurman. Also the driver carrying the microphone for the occasion was arrested.
- 3/ On Tuesday 12/09/2017 **Ms Hanadi sidig** a journalist, was arrested by NISS, beaten and vulgarly insulted.
- 4/ On Friday 15/09/2017 **Mr Ibrahim Mustafa**, student at Alhshisa town was arrested and beaten by NISS.
- 5/ On 24/09/2017 many persons including **Dr Zain alabdin Mohamed Nassir** was arrested by NISS outside court yard when seeking to attend the trial of student **Mr Asim Omar**.
- 6/ On Sunday 24/09/2017 NISS arrested students in Kordufan unversiry in elobaid including **Mr Mohamed Mustafa Yousif, Mr Mustafa Sidig, Ms Niama Abdelrhman** and **Mr Mustafa Ibrahim** as they were part of peaceful protest against death sentence passed against student **Mr Asim Omer** on 29/08/2017.

7/ On 25/09/2017 NISS arrested journalist **Ms Marwa Eltjani** for alleged religious apostasy.

8/ On 03/10/2017 NISS arrested **Mr Tariq Mansour** from his house and taken to unknown place. Also student from Ahlia University Omdurman were arrested by NISS including **Mr Mohamed Almutaba, Mr Mohamed Salah, Mr Sadam Alzain, Mr Talha Elasyed** while in a peaceful protest in solidarity with other students in the same university denied access to university.

9/ On Sunday 22/10/2017 police force under colonel **Mr Nagmeldin Badreldin** invaded Christ church Alsawra Alharah No 29 Omdurman and banned Christian from entering the church for prayers. They arrested the priests and leaders of the church names hereunder:-

10/ On Friday 27/10/2017 NISS banned **Mr Alaeldin Mahmoud**, Sudanese journalist at Sharga ( UAE ) from leaving Sudan to UAE. **Mr Alaeldin** came to Sudan in a vacation and was not allowed to return for his work.

11/ On 17/10/2017 **Mr Omer Oshari** and **Mr Bakri Algami** were arrested by NISS for expressing their solidarity to women who serve tea to costumers to support their family. The government doesn't support this women nor allow them to make and serve tea.

12/ On Thursday 19/10/2017 **Mr Abdelwahab Mohamed Nour** and **Mr almigdad Khidir** ( student ) were arrested by NISS for distributing leaflet in support of Aljazeera peasants on Land Day. They were subjected to continuous torture and denied any visit.

13/ On Monday 13/11/2017 **Mr Alaeldin Babiker**, a journalist, was arrested by NISS at aljinina Darfur and taken unknown place.

14/ On 27/11/2017 **Mr Mohamed Abdelwahab** , member of DUP united was arrested by NISS.also **Mr Airwa Alsadig**, human rights activist was arrested by NISS.

15/ On 08/12/2017 **Mr Nasreldin Mukhta** , leader of Darfur student association at Quran Karim university was arrested by jihadist group of national congers party, the role in party. He was chained and handcuffed and beaten, he incurred injures on his hands and legs and lost one aye due to beating and torture.

17/ Human rights activist **Ms Wini** was arrested because of her dress. **Mr Montisir Ibrahim AElzain**, a human rights activist and writer was also arrested 12/12/2017 because he defended her. He refused to be released saying that he cannot raise his children without dignity.

18/ On 12/12/2017 **Ms Madiha Abdellah**, ex -chief of Midan newspaper, was fined and sentenced to imprisonment in lieu of fine for free expression of opinion.

19/ On 13/12/2017 **Mr Hamroor Hussain Hamroor** , leader of DUP, was arrested by NISS because of his article in a newspaper and was taken to unknown place.

20/ 27/12/2017 **Mr Hassabo Ibrahim Mohamed**, chairman of Aljazeera Farmer Union was arrested by NISS from his house.

21/ On 31/12/2017 **Mr Mohamed Alhassan Alihimir**, leader of DUP united at Kassala, was arrested by NISS.

22/ On 07/01/2018 **Mr Galal Mustafa Amin** and **Mr Omer Aldigeer** from Sudan congress party were arrested by NISS.

23/ On 08/01/2018 NISS arrested **Mr Ahmed Zohair**, **Mr Mohiedin Galad** and **Mr Ali Hago** and **Mr Adil Khalfallah**.

24/ On 13/01/2018 NISS arrested 18 persons from Aslaia including **Mr alzobir Ahmed**, **Mr Ali Aboud**, **Mr Suliman Omer Ahmed**. **Mr Mohamed Ahmed Omer**, **Mr Adam Mousa Ahmed** and others.

48. On 10/05/2018 Human rights activists were arrested in Khartoum for preparing a work shop.
- 49/ **Mr Hisham Ali Mohamed Ali** was working in Saudi Arabia. NISS asked Saudi Arabia intelligent to arrest him and deport him to Sudan because he criticized in Facebook Sudan NISS. He was accordingly arrested and detained in Saudi Arabia on 18/11/2017, and on 29/05/2018 he was deported under arrest and handed to NISS in Khartoum. He was severely tortured in Khartoum and denied for a long time access to family and Lawyers. Those who protested from his family were arrested by NISS including **Ms ameera Abbass, Dr Jalal Mustafa** and **Mr Mohamed Moatasim Alkabashi**.

### **Conclusion**

It is evident that Khartoum regime is insisently violating Human Rights, and shall not refrain from so doing as the President of the regime is wanted by ICC and shall not leave power aspiring to be protected from ICC Warrants of arrest or at least to hinder and delay his arrest. He is now in power for Six terms in office and seeks to amend the constitution for a Seventh Term. His only means are to supress the opposition by arresting, detaining torturing and killing any person who raises the slightest gesture of opposition.

He shall continue to violate human rights. It's the duty of the international community to limit such violations if it cannot stop them. Referring Sudan to article Four is the best way to supervise such violation.
